2. As on 1<sup>st</sup> May 2019, the total outstanding consolidated order book position of the Company is Rs. 235.11 crores out of which Rs. 133.65 crores worth of orders are for Indian market and Rs. 101.46 crores worth of orders are for markets outside India.

Of the total outstanding consolidated order of Rs. 101.46 crores for markets out of India, Rs. 61.25 crores constitute orders for USA market and Rs. 40.21 crores constitute orders for rest of the world.
