CORPORATE ANNOUNCEMENT

Dear Sir/ Ma'am,

This is to inform you as under:

- 1) In the month of June 2021, the consolidated orders received by the Company are worth **Rs. 46.41 Cr** out of which orders worth Rs. 14.10 Cr are for Indian market and orders worth Rs. 32.31 Cr are for markets outside India.

The significant contributors to the monthly order booking of June 2021 are L&T- Chennai, Rajkamal Builders-Ahmedabad, Jyoti Limited-Vadodara & LC Infra Projects-Ahmedabad from India and Atal Engineering-Hong Kong, Onshore Construction-Nigeria, Bird Island-USA, Hanna St-USA & Pacoima-USA from International market.

- 2) As on 1st July 2021, the total outstanding consolidated order book position of the company is **Rs. 460 Cr** out of which orders worth Rs. 163 Cr are for Indian market and orders worth Rs. 297 Cr are for markets outside India.

Of the total outstanding consolidated orders worth Rs. 297 Cr for markets outside India, Rs. 131 Cr constitute orders for USA market and remaining Rs. 166 Cr constitute orders for Rest of the World.

- 3) As on 1st July 2021, consolidated orders worth **Rs. 30 Cr** have been negotiated with clients & formal Purchase Orders are awaited. Out of this Rs. 21 Cr worth of orders are for Indian market and Rs. 9 Cr worth of orders are for markets outside India.

After negotiating an order, it may take up to 2 months to receive a formal Purchase Order from the client. Once a Purchase Order is received, we remove its value from the list of "negotiated orders" and move it to list of order received in a given month and add it to the total outstanding consolidated order book position of the Company.

- 4) In the month of June 2021, we have received first order for 2 Nos. Disc Filter Machines for a Project in India. This marks our entry into the growing business of equipment for improved waste water quality before discharge to water bodies.
