

(17.63) lakhs for the quarter ended 30 June 2023, total comprehensive loss of Rs. (17.57) lakhs for the quarter ended 30 June 2023 considered in the Statement. These interim financial information have been reviewed by other auditor whose report has been furnished to us by the Management and our conclusion on the Statement, in so far as it relates to the amounts and disclosures included in respect of the subsidiary, is based solely on the report of the other auditor and the procedures performed by us as stated in paragraph 3 above.

Our conclusion on the Statement is not modified in respect of this matters.

7. The Statement includes the interim financial information of three subsidiaries which have not been reviewed by their auditors, whose interim financial information reflect total revenue of Rs. Nil lakhs for the quarter ended 30 June 2023, total loss after tax of Rs. (28.50) lakhs for the quarter ended 30 June 2023, total comprehensive loss of Rs. (28.50) lakhs for the quarter ended 30 June 2023, as considered in the Statement. According to the information and explanations given to us by the Management, these interim financial information are not material to the Group.

Our conclusion on the Statement is not modified in respect of our reliance on the interim financial information certified by the Management.

The statement includes the results for the quarter ended 31 March 2023 being the balancing amount between the audited amounts in respect of the full financial year and the published year to date amounts up to the third quarter of the financial year ended 31 March 2023 which were subjected to limited review.
- 9. The comparative financial information of the Group for the quarter ended 30 June 2022, prepared in accordance with Ind AS, included in this Statement have been reviewed, as applicable, by the predecessor auditors. Our conclusion on the Statement is not modified in respect of above matter.




